

ERASMUS MOBILITY PROGRAM

Application Criteria;

1. You must be a registered student at ABU at the time of logging an application.
2. Vocational School & Undergraduate students must have a minimum of 2.20 CGPA and have completed 1 regular semester before application. **Erasmus + Mobility Program is especially offered for 2nd or 3rd year students.**

*****Students has less than 2.20 CGPA (vocational school, bachelor degree) 2.50 (master degree) are not available to apply.**

*****Erasmus + Mobility Program is especially offered for 2nd or 3rd year for bachelor students.**

3. Students must pay the full fee to ABU and *not to the Host Institute*.
4. You need to complete the application form by entering your university username and password at <https://exchange.antalva.edu.tr/>
5. The weighted score for selection will be comprised of: **50% from English proficiency + 50% from CGPA.**
6. Participants who has special conditions will be given priority;

Disable students will take + 10 points (You can get more information) https://ec.europa.eu/programmes/erasmus-plus/opportunities/individuals/physical-mental-conditions_en
Martyr / veteran children or spouse will take + 15 points. Please contact Erasmus Office to get more information. **You need to choose this option from the system. (please check the guide)**

7. Students who are double major will fill in the application form by selecting a department. The responsibility of the student is to give information to each of the two departments. Erasmus cannot be done from the **minor field**.

ERASMUS+ KA103 Erasmus European Mobility Program

What is Erasmus+ KA103 European Mobility Program?

Erasmus+ European Mobility is a program that enables student and staff mobility between higher education institutions (HEIs) of 28 EU member countries plus Iceland, Liechtenstein, Norway, the FYR of Macedonia, and Turkey. To participate in this program HEIs of these countries apply to European Commission to be able to get eligible for Erasmus Charter for Higher Education (ECHE). International cooperation between HEIs in these countries is established through bilateral student and staff mobility agreement.

IMPORTANT NOTES:

- 1) All participants should abide by the allocated budget constrains since no extra funding is available. (KA103)
- 2) Students who benefited from Erasmus+ study and/or internship programs or other mobility programs offered by the university will receive 10pts penalty in their ICM placement points for each time they took part in a mobility program. For one mobility program 10pts, for two mobility programs 20pts, for three mobility programs 30pts penalty will be applied. (KA103)
- 4) If the student wants to extend the Erasmus mobility to the second semester, he / she has to study the second semester at the same university.
- 5) If the student wishes, he / she can benefit from the Erasmus Program **online** without traveling, **but cannot receive a grant. The student who will benefit from the Erasmus program must physically exchange in order to receive a grant.**
- 6) Participants are able to participate in Erasmus+ Mobility for Students Mobility program without receiving a grant. However, it should be noted that they still have to go through the same application & selection procedures and also submit the required documents (before-during-after mobility) to Erasmus Office of Antalya Bilim University even though they will not receive the funding.
- 7) Students will be granted totally 4 months for studying mobility, and totally 2 months for internship.

IMPORTANT: Organizing the Erasmus exam and announcement of the results must be transparent. For this reason, the applicant's name, surname, school number, department, English exam score, CGPA and final result must be published on the website and sent by e-mail. Please take this into consideration when you apply Erasmus Program.

APPLICATION DOCUMENTS

1. You need to complete pre-registration and you need to complete your application from the web site: <https://exchange.antalya.edu.tr/>
2. The guidebook of application process is attached by e-mail.
3. ***If you want to study on fall semester of 2021-2022 Academic Year;
you need to choose 2021-2022 Fall,

***If you want to study on spring semester of 2021-2022 Academic Year;
you need to choose 2021-2022 Spring,

***If you want to benefit from internship program for summer term of 2020-2021 Academic year (this summer);
you need to choose 2020-2021 Summer,

***If you want to benefit from internship program for summer term of 2021-2022 Academic year (next summer);
you need to choose 2021-2022 Summer.

4. If you have English Language Result, please upload this to the system and this score will be accepted on the period of evaluation.

TOEFL is accepted if it was taken in last two years. Minimum score is 72.

YÖKDİL/ YDS is accepted. Minimum score is 60 for bachelor degree, 70 is for master degree.

5. If you don't have any English certificate, you need to attend the Erasmus English Exam which will be organized by Antalya Bilim University Foreign Language School. **Otherwise you will not able to benefit from Erasmus Program in any way!**

NOTE:

- 10 Points to be reduced; Students who previously benefited from the Erasmus + Mobility at the same level of education, Students who entitled to be an Erasmus student in the period of previous exam term within the same level of education but renounce an Erasmus right without a compelling excuse Students who are entitled to practice Erasmus + Mobility renounce their rights for any reason, if they do not submit their petition until the release date announced by Erasmus Office
- * **TOEFL is accepted if it was taken in last two years. Minimum score is 72.**
- * **YÖKDİL/ YDS is accepted. Minimum score is 60 for bachelor degree, 70 is for master degree.**

FINANCIAL SUPPORT:

The European Commission may offer financial support to selected students. The amount of the monthly grant is determined each year by the National Agency and announced in the Application Guide.

- Students are required to sign “**Erasmus Grant Agreement**” to receive their Erasmus grant.
- The students who benefit from the EU grant will provide the office with their Euro bank account (Vakif bank) details with an official document and following this, a Grant Agreement is formed and signed by both ABU and the student.
- Upon the completion of signatures, 80% of the total grant is transferred to the student’s account. 20% is paid after the student fulfill all the requirements, if not, remaining amount will not be transferred. Payments will be made in Euros.
- Paid financial support in not meant to be reimburse, it is for financial assistance for mobility.
- The real amount is calculated according to documents that students submit to Erasmus Office at the end of their program.
