This course is designed to introduce students the basics of conducting research in social

sciences. The objective of the course is to inform students about different research methodologies and

analyses in social sciences. For this purpose, the course provides a general overview of quantitative

and qualitative research methods. At the end of this course, students are expected to develop a

fundamental understanding about research design, data collection and data analysis. The course is

expected to provide a roadmap for graduate-level students to design their original research projects.

Research paper's submission date is 25 December 2024, 17.00 p.m. the latest.
- **5)** Research project presentation (%5) Students are expected to present their research to their professors and fellow students during the last two weeks of the semester.
- **6) Final exam (50%)**: Students are responsible from all class material covered after the midterm as well as the research paper they prepare during the semester.

Guidelines for the Research Project

The research project for POLS 703 course intends to provide students the opportunity to experience research design and execution, by utilizing one of the research methods taught in this course. For this reason, the students should first find a political science-related study, which presents a detailed discussion about its research method. As a second step, the students are expected to replicate this study. This replication may be much narrower in its scope, yet it should be an exact replication in terms of its research method.

Hence, there are three components of the research project:

- 1) Research proposal submission, due 6 November 2024 (5% of overall grade)
- 2) Research paper submission, due 25 December (15% of overall grade)
- 3) Research paper presentation, 18 and 25 December 2024 (5% of overall grade)
- 1) Research proposal submission: Before the project execution, students are expected to submit a research proposal by 6 November 2024, 17.00 p.m. the latest. Any late submissions after this date/time are subject to 20 points of reduction for each additional day of late submission. Late submissions on 20 November 2024 (after 17.00 p.m.) are subject to 10 points of reduction.

<u>The students can only proceed to undertake their proposed research once their proposal is approved by the course instructor.</u>

Below are the questions the students are supposed to reflect upon for their research proposal submission:

- 1) What is the main focus of your research? What is your research question?
- 2) Which article/study guides you in your research? Provide full reference.
- 3) What is the main research focus of this article?
- 4) Which method did this article utilize in its analysis?
- 5) What are the main findings of this article?
- 6) How will you replicate the method of this study in your own research?
- 7) Explain your research design.

All questions should be answered separately. The proposal should be written in a Word document, 12 fonts, Times New Roman with 1,5 spacing between the lines. Please print out and submit your proposal as a hard copy. Electronic submissions are not accepted.

2) Research paper submission: The students must submit their research that was approved in their respective proposals. Submission of a research project that is different than the one explained in the proposal will receive an F. The research paper will be evaluated according to the following criteria:

a) Did the student execute his/her research design effectively?

b) Is the research paper clear about its research method?

c) To what extent does the analysis rely on original data analysis?

d) Does the analysis consistent with its research question and research design?

The students are expected to submit their research projects on 25 December 2024, 17.00 p.m. the latest.

Any late submissions after this date/time are subject to 20 points of reduction for each additional day

of late submission. Late submissions on 3 December 2019 (after 17.00 p.m.) are subject to 10 points of

reduction.

The research project should be written in a Word document, 12 fonts, Times New Roman with 1,5

spacing between the lines. The minimum length is 10 pages and the maximum length is 15 pages,

including the research design and references sections. Please print out and submit your research paper

as a hard copy. Electronic submissions are not accepted. The research project should include the

following sub-sections:

1. Abstract

2. Introduction

3. Literature Review

4. Methods & Data

5. Results

6. Discussion & Conclusion

7. References

3) Research paper presentation: The students will present their research during the 13th &14th

weeks of class. The presentation should be approximately 15 minutes. You should utilize PowerPoint

to help visualize your work. The presentations will be evaluated according to following criteria:

a) Clear communication of the research objective

b) Clear communication of the research method

c) A discussion of challenges encountered during data collection and analysis

d) A clear discussion of research findings

e) A clear discussion of the project's scientific and social relevance
