1.SEMESTER COMPULSORY COURSES

HUK 101 Introduction to Law and Basic Concepts

Within the framework of this course, firstly, what law is as a whole is introduced in terms of its functions. Thus, the indispensability of law in social life is emphasized in terms of its meaning in terms of order, meeting social needs and especially justice. In this way, the differences between law and similar concepts such as morality and custom are revealed. Then, the characteristics of the various sciences that will investigate law and the relations of legal sciences with practice are explained.

HUK 103 Civil Law I

Within the scope of this course, the initial provisions of the Civil Code and the real and legal persons, associations and foundations, the person's rights and capacity to act, the beginning and termination of personality, the right of personality and ways of protection, the classification of rights, the changes brought by the new Civil Code are explained in comparison with the old regulations.

HUK 105 Constitutional Law I

Within the scope of this course, the general principles and basic concepts of constitutional law are explained, especially in comparison with liberal western democracies. The topics of the course include the constitution, making and amending the constitution, constitutionality review, political power, sovereignty, the concept of state, forms of state, organs of the state, constitutional state and constitutionalism movements, legislative-executive-judicial appendices, political regimes (government systems), parliamentary government regime, presidential regime, parliamentary regime, political parties, democracy, elections, election systems, fundamental rights and freedoms, etc.

HUK 107 Roman Law

In this course, after a brief introduction to the political structure of the Roman Empire; the foundations, history and sources of Roman Law and Corpus Iuris Civilis will be emphasized. In addition, the effects of Roman procedural law on the concepts of Civil Procedural Law and the reflections of Roman Property Law concepts in Modern law will be given. The concept of debt in Roman law, its nature, the subject of debt rights, the impossibility of performance, the birth of debt, the Roman system of contracts and their types, contract similarities, debts arising from tort, the transfer and termination of debt rights in Roman law (performance, release, exchange) The points reached in the field of Roman Law of Obligations and the comparison with the Turkish-Swiss Law of Obligations system will be given.

HIST 101 Atatürk's Principles and History of Turkish Revolution I

In this course, the history of the Turkish War of Independence, foreign relations of Atatürk's period, national sovereignty and Atatürk's principles and revolutions are explained. In this context, especially the reflections of the political changes and nationalism movements that developed with the French Revolution on the last years of the Ottoman Empire and the discussions on the struggles of ideas that emerged in the multi-party constitutional system in the Ottoman Empire before the years of the National Struggle; the new political environment that developed with the establishment of the Republic and the problems experienced here; the problems experienced in the process of institutionalization of the dynamic, progressive and Western civilization-oriented state structure put forward by Atatürk's principles and their reflections in today's Turkey are examined.

HUK 102 Civil Law II

Within the scope of this course, the basic concepts and institutions of family law such as engagement, marriage, general provisions of marriage, dissolution of marriage, property regimes, paternity, adoption, alimony, custody, guardianship, trusteeship and legal counseling are explained by supporting practical studies.

HUK 104 Constitutional Law II

Within the scope of this course, Ottoman-Turkish constitutional developments and the freedoms regime envisaged by the current constitution and the constitutional system in the perspective of the concepts learned in the General Principles of Constitutional Law course are explained. In particular, the historical development of Turkish Constitutional Law (Constitutions of 1876, 1921, 1924 and 1961) and the basic principles of the 1982 Constitution, the organization of the legislative, executive and judicial organs and the relations between them, extraordinary administrative procedures and other institutions regulated in the Constitution and the establishment and functioning of the Constitutional Court will be discussed.

HUK 106 History of Turkish Law

In this course, in general, the social, economic, cultural or geographical influences under which the legal rules in force in the past were formed, which needs these rules emerged to meet, what kind of interactions between political and social developments and the legal order are discussed. In addition, the historical development of legal institutions and rules is explained by comparing them with different legal systems. This course is mainly analyzed under two main headings: - The period after the proclamation of Tanzimat (a mixed period in which Western law and Islamic law dominated together, which started with the declaration of the Sened-i İttifak and the Tanzimat), the period after the proclamation of the Republic (a modern period in which Western law and principles were adopted with the proclamation of the Republic).

In addition, important movements of our time such as globalization are explained in detail.

HUK 201 Law of Obligations (General) I

The content of this course includes general principles of the law of obligations, especially contracts, formation of contracts, offer and acceptance, capacity to contract, fundamental and non-fundamental error, fraud, threat, gabin, contractual obligations, freedom to contract, limitation of this freedom in the face of public order and mandatory provisions, obligations arising from torts and unjust enrichment.

HUK 203 Administrative Law I

In this course, the concept of administration is defined and the elements and characteristics of Turkish administrative organization are emphasized. The elements of both centralized administration and decentralized administration principles are conveyed to the students by taking into consideration the recent legal amendments. In addition, the concept of public personnel and related rights and obligations and disciplinary law are also examined in the light of the decisions of the Council of State. The concept of public property is defined and the legal regime and utilization procedures of public property are explained.

HUK 205 Criminal Law (General) I

The content of this course consists of the introductory issues of criminal law and the issues related to the application area of the criminal law. In this context, the function of criminal law, its place in the legal order, the basic concepts of criminal law, the basic principles of criminal policy, the assurance function of criminal law (the principle of legality in crime and punishment), the sources of criminal law, the application of criminal law in terms of time, place and person, and the return of criminals are discussed.

In addition, special debt relations such as joint and several indebtedness and contingent debts and the concepts of assignment of receivables and transfer of debts are also examined.

HUK 206 Criminal Law (General) II

In this course, crime theory and sanction theory are discussed. In this framework, the elements of crime, culpability, other conditions of punishability, negligent crimes, attempt, participation, aggregation, penalties and security measures as types of sanctions, reasons that reduce the case and punishment are examined.

HUK 208 General Law of States II

The resolution of international disputes, the use of force by states; the international judicial mechanism as a peaceful settlement of international disputes, its functioning and importance, the United Nations Organization, its role, organs and activities will be given as the main subjects of the course. The human rights element in international law and international humanitarian law will be discussed.

HUK 210 Tax Law

Sources of tax law and interpretation in tax law, taxation authority, the limits of taxation authority in the international arena, the concepts of tax duty, tax liability and tax responsibility and the concepts of levy, notification, accrual, collection as taxation transactions, periods in tax law, the reasons that terminate the tax debt, securing the tax receivable, remedies in tax disputes, tax crimes and penalties, taxes on income, taxes on wealth, taxes on expenditures, tax liability, tax trial and trial procedure.

HUK 301 Property Law I

Special types of contracts such as franchise, factoring and license agreements are discussed.

The control mechanisms to which the administration is subject and the administrative judicial procedure are introduced to the students through practical studies. For this purpose, the course covers the administrative jurisdiction authorities, the time limits for filing a lawsuit in administrative jurisdiction, the classification of the courts to be applied in administrative jurisdiction according to the nature of the administrative act, the duties and jurisdiction of these courts, as well as the types of cases in administrative jurisdiction, the implementation of court decisions, the principles of responsibility and the ordinary and extraordinary remedies.

HUK 313 Philosophy of Law

The main topic of this course is "justice". The philosophical conceptualization of this term will reveal that justice is a demand and injustice is a fact. We will then compare and contrast how this concept is treated by various currents in the philosophy of law. From Aristotle's 'distributive' justice to Bentham's 'utilitarian' justice, from Kant's understanding of justice based on 'respect for human beings' to Rawls' concept of 'fairness', the concept of justice is discussed and analyzed. Finally, the extent to which those living today can be responsible for the injustices committed in the past is discussed by giving examples.

Special types of contracts such as franchise, factoring and license agreements are discussed.

HUK 401 Inheritance Law

Inheritance Law deals with the fate of the rights and debts and other legal relations that can be transferred upon the death of a person we call the heir. In this context, the basic concepts of inheritance law (heir, heir, inheritance, probate, succession, etc.), legal heirship, the concept of testamentary disposition and types of testamentary disposition, reserved share, equalization, inheritance (inheritance), acquisition of inheritance (acquisition) and division of inheritance are examined.

HUK 403 Enforcement and Bankruptcy Law I

In this context, general information about enforcement law, types of enforcement, enforcement organization, complaint, enforcement fees and expenses, notification, periods, vacation and talik cases, parties of enforcement proceedings, enforcement proceedings through general attachment, cancellation of objection, removal of objection, negative assessment and reclamation cases, cancellation and cancellation of enforcement proceedings, declaration of property, Participation in foreclosure foreclosure, foreclosure procedure, payment of debt in installments, sale, termination of the tender, concepts and institutions of insolvency certificate, foreclosure of bills of exchange, evacuation of leased immovables, enforcement by writ, foreclosure by foreclosure of pledge, precautionary attachment and enforcement crimes will be explained.

HUK 405 Criminal Procedure Law I

The content of this course includes the purpose and function of criminal procedure, the sources of this branch of law, the interpretation of the sources, the application of the rules of criminal procedure in terms of place, time and person, the conditions of judgment, the function and characteristics of the investigation phase, the subjects of the investigation phase, the collection of evidence in the investigation phase, protection measures and the conclusion of the investigation.

HUK 407 Private Law of States I

The aim of the course is to provide the students with the methods of application of our private international law rules, especially when the application of foreign laws may be in question. In the first semester, the legal nature and types of conflict of laws rules in private international law, the concept of attribution, binding rules, fraud against the law, contradiction of norms and adaptation, preliminary issue, the principle of public order, the element of foreignness according to Turkish law, the application of foreign law, general doctrines in citizenship law, general principles in Turkish citizenship law, acquisition and loss of citizenship, proof of citizenship and judicial remedy are discussed.

HUK 409 Labor Law

In this course, employee-employer relations, which are the source of labor disputes that occupy a wide area in practice, will be examined. In this context, historical development of labor law; basic concepts in labor law (employee, employer, apprentice, trainee, employer representative, subcontractor, workplace and enterprise); employment contract, elements and types of employment contract, validity and invalidity of employment contract, basic and side debts arising from employment contract, regulation of work (working time, paid holidays and annual paid leave), termination of employment contract and its consequences will be explained.

HUK 411 Maritime Trade Law

In the Maritime Law course, the basic concepts of Maritime Law such as ship, captain are examined. The responsibility of the shipowner and the shipowner is explained. Freight contracts are analyzed. The place and definition of charterparties within charterparties are examined, with particular emphasis on ship allocation contracts. First of all, while mentioning ship allocation contracts, the place of charterparties within ship allocation contracts is determined and defined comparatively. The types of charterparties, their unique features and common features are examined. Within the scope of the course, the concepts such as carrier, shipper, shipowner, owner, charterer in charter contracts are filled in and the legal responsibilities of these persons are mentioned. The type contracts used in practice are translated and evaluated comparatively. Termination of the freight contract is analyzed.

In the course of the law of negotiable instruments, especially the concept of negotiable instruments, its types, its formal conditions and provisions, its loss and cancellation, the formal conditions, transfer, payment and consequences of non-payment in terms of policy, check, bond, bill of receipt and warrant are examined.

8. SEMESTER COMPULSORY COURSES

HUK 402 Philosophy of Society

In Western universities, the subjects of "society/state/political philosophy" are often taught together. The aim of the course is to explain these three huge subjects and problem areas in the most appropriate way to the final year law students. Following the examples of "utopia" in Western thought in Plato, Morus and Campanella, the "utopian socialist" (Fourier, Saint-Simon) and "socialist" (Marx, Engels) thinkers of the 19th century are analyzed. The main ideas of Auguste Comte, Emile Durkheim and Max Weber, the founders of sociology, are discussed. The 20th century evolutionist and conflictualist theories of society as well as the views of Ibn Khaldun and Ziya Gökalp from the Islamic world are analyzed. Finally, the "Westernization" and "modernization" adventure of the Republic of Turkey is examined from the perspective of philosophy of society.

HUK 404 Enforcement and Bankruptcy Law II

Within the scope of the Execution and Bankruptcy Law, the following subjects are explained: proceedings through bankruptcy, bankruptcy case, direct bankruptcy cases, abolition of bankruptcy, legal consequences of bankruptcy, liquidation of bankruptcy, procedures on how the merchant can be bankrupted and concordat, restructuring of capital companies and cooperatives through reconciliation, liquidation of goods after bankruptcy and satisfaction of receivables.

HUK 406 Criminal Procedure Law II

The content of this course consists of the procedures carried out in the prosecution phase of criminal procedure. In this framework, the powers of the criminal court authorized in the prosecution phase in terms of article, place, person, the qualifications of the judges, independence and impartiality, the connection between the disputes, the stages and characteristics of the trial phase, legal remedies and special trial procedures are emphasized.

In the second semester, the application rules of private international law in personal law, family law, law of descent, law of inheritance, law of property and law of obligations, form and statute of limitations in legal transactions and the principle of lex fori in international procedural law, qualification, relationship with substantive law, international jurisdiction rules, Turkish international jurisdiction system, recognition and enforcement of foreign court decisions, international arbitration, enforcement of foreign arbitral awards, international judicial assistance, freedom of foreigners to work in Turkey, real estate acquisition rights and inheritance rights are covered.

The concept of Social Security and its historical development, Social Security in international law and European law; Principles and financing of Social Security; Sources of Social Security law, its place in the legal system, reform in the Turkish Social Security System; Application area of social insurances (concept of insured, insurance period), administrative management of social insurances; Financing of social insurances

Premiums as a source; Types of social insurance (work accident and occupational disease insurance, sickness insurance, disability insurance, old age and death insurance); Unemployment insurance; Right to health and general health insurance; Private pension; Social assistance and social services are the subject of this course.

Meaning and historical development of human rights, Human rights theory, International human rights supervisory systems, application method to the European Court of Human Rights, jurisprudence of the European Court of Human Rights, prohibition of discrimination, right to equality, freedom of expression, freedom of association, religious freedoms, right to elect and be elected, right to education, minority rights, Human Rights in the EU are the topics to be examined.
