Then the difference between 'value' and 'values', which is the main subject of the 'Philosophy of Value', which is usually discussed together with ethics, is explained. This difference will also reveal the difference between human and personal values. Finally, the topic of 'action evaluation', which is extremely important for law students, is discussed.

This course is offered as a specialization course for students interested in public international law. The use of force has always been a part of relations between states. However, especially starting from the XIXth century, the humanitarian dimension of the military activities of different states has been addressed. Civilians and armed forces were considered to have certain rights that should be protected by hostile states. In particular, in this course, students will be introduced to the history of the development of international law and the history of conventions (including the Geneva Conventions of 1949 and the Additional Protocols of 1977). The historical analysis will make it useful to critically examine issues in the field of international law by identifying the rights protected and the efficiency and/or inefficiency of protection actually proposed.

This course not only enables law students to realize the importance of a philosophical conceptualization of fundamental rights and freedoms, but also to gain a certain sensitivity in the use of concepts such as 'democracy' and 'secularism'.

As a complementary part of the course, at least two day trips to the immediate surroundings of Antalya will be organized and students will be exposed to concrete examples.
